Re: **Annual California Proposition 65 Notice; Review and Response Required**

Dear Valued Customer:

California's Safe Drinking Water and Toxic Enforcement Act of 1986, commonly referred to as "Proposition 65" or "Prop 65," is a "right to know" law that requires companies to provide warnings if a product can expose individuals to a chemical known to the State of California to cause cancer or reproductive toxicity. There are more than 850 chemicals on the Proposition 65 list of such chemicals. Under the new warning regulations, we have a duty to inform our customers of the warning requirements and to take reasonable steps to ensure that our customers are properly providing the warnings. This is to notify you that we manufacture and distribute to you parts or products that contains a chemical on the Proposition 65 list, Di(2-ethylhexyl) phthalate, otherwise known as "DEHP" and thus, we are providing you with the following warnings:

⚠ WARNING: Cancer and Reproductive Harm – www.P65Warnings.ca.gov.

The above warning, in accordance with regulations, will be included on the packaging of all retail packaged items. If you are a distributor of any of these products, you must provide a clear and reasonable warning to your retail customers along with a letter explaining the obligations of Proposition 65, and must take reasonable steps to ensure retailers are properly providing the warning to end customers. If you are a retailer of any of these products, you must ensure that your customers receive the Proposition 65 warning via the methods required by the relevant regulations. We encourage you to consult with legal counsel to determine whether you may provide the short-form warning provided above, which is allowed under the regulations under certain circumstances, or the long-form warning provided in the footnote below.¹ Further information about Proposition 65 can be found at: <https://oehha.ca.gov/proposition-65/proposition-65-faqs>.
